Chhattisgarh Rajya Sahakari Dugdh Mahasangh Maryadit, Urla, Durg reserves the right to accept or reject any or all tenders, which in their opinion justify such actions, without further explanation to the tenderers.

### 1.0 Scope of Work:-

The bidder shall have to quote rate inclusive of GST and work will be done as per detailed specifications given in the schedule –III

### 2.0 Required qualification of the bidder:-

The bidder must have:-

- 1. Certificate for Registration/Authorization of party from Boiler Department CG.
- 2. Registration for GST
- 3. Valid & active PAN issued by I.T. Department.
- 4. The bidder must attach self attested the documentary proof for all the above criteria.

### **3.0 DECLARATION:**

The submission of a tender by a tenderer implies that he/she has read the notice and conditions of the tender and the terms and conditions of contract and has made himself/herself aware of scope and specifications of the supplies to be made and the destination where the supplies have to be made and satisfied himself/herself regarding the quality and specifications of the articles.

- 4.0 The tender should be sent by **Registered/ Speed post only**. Bids received through courier service/by hand / any other means shall not be considered. Chhattisgarh Rajya Sahakari Dugdh Mahasangh Maryadit, Urla, Durg, shall not be responsible for any postal delay.
- **4.1** Individuals signing on the tender and other related documents must specify in which capacity of the firm he/she has signed the documents.
- 4.2 The tenderer(s) should clearly state in their offer the address, telephone, fax, e-mail, & GST No. Any change in the address should immediately be communicated to the Managing Director, Chhattisgarh Rajya Sahakari Dugdh Mahasangh Maryadit, Urla, Durg, and correspondence thereafter will be made at the changed address.
- **4.3** Negligence on the part of tenderer in filling the tender form offers him/her no right to withdraw tender after it has been opened.
- 4.4 The acceptance of the tender and award of the purchase order will be the sole right of the Managing Director, Chhattisgarh Rajya Sahakari Dugdh Mahasangh Maryadit, Urla, Durg,. who does not bind him self to accept a tender in whole or in part or reject any or all the tenders received without assigning any reasons and no explanation can be demanded of the cause of rejection of the tender by any tenderer.
- 4.5 The tenderers should send their offers along with the specifications, necessary drawing (if required) which will form the basis of their offer and is an integral part thereof.
- 4.6 The Managing Director, CGCDF reserves the right to place order for whole requirement with any tenderer or split the orders among one or more tenderers or not to purchase at all any item even after rate approval.
- **4.7** The tenderers should submit the tender in the enclosed rate form -B only in schedule-II The conditional tenders are liable to be rejected.
- **4.8** No person or firm is permitted to submit more than one tender under different names.

- **4.9** Each page of the tender and its enclosure should be signed at the bottom by the tenderer.
- **4.10** The tenderer shall not sublet the contract or assign to any other party or parties, the whole or any portion of the contract without prior written permission of Managing Director, CGCDF.
- **4.11** Demonstration of equipment, machines or articles available with the firm shall be arranged by the tenderer at his own cost, whenever requested by Chhattisgarh Rajya Sahakari Dugdh Mahasangh Maryadit, Urla, Durg,

### **6.0** EARNEST MONEY DEPOSIT

- All the tenderers are required to deposit fresh Earnest Money as specified in tender document, for each item either in cash or in the form of crossed demand draft / bankers ch. in favour of Chhattisgarh Rajya Sahakari Dugdh Mahasangh Maryadit, payable at Raipur. Submissions of earnest money by any other mode than specified above shall not be acceptable and the related tender shall not be eligible for consideration. Previous EMD amounts of any firm if lying with CGCDF for any or for same items shall not be considered against this tender reference. All previous EMD amounts of firms will be refunded by CGCDF in due course of time after expiry of last approved period.
- 6.2 Any tender which is not accompanied by Earnest Money deposit are liable to be rejected. Earnest money deposit of unsuccessful tenderers will be returned within 90 days from the date of opening of the tender. The earnest money deposit of the successful tenderers will be released on completion of supply/work as the case may be within the stipulated period.
- 6.3 No interest will be paid on the earnest money for the period during which (the EMD) lies in deposit with Chhattisgarh Rajya Sahakari Dugdh Mahasangh Maryadit, Urla, Durg,
- **6.4** Demand Draft towards earnest money or the original money receipts (in case of cash deposits) should be submitted enclosed along with the tender offer in sealed cover.

### 7.0 **PRICES**

- 7.1 Rate should be quoted for the work as per the specifications given in the schedule III of the tender document.
- 7.2 In case of any doubt as to the meaning of any of the terms & conditions or the specifications, the tendering firm may set forth the particulars there of and submit them to the Chhattisgarh Rajya Sahakari Dugdh Mahasangh Maryadit, Urla, Durg., in writing that such doubts may be removed before submitting the tender.
- 7.3 The rates be quoted in figures and preferably no cuttings/overwriting in rates should be there in tender.
- 7.4 Prices offered by the tenderers should be firm and free from all escalations and shall be valid at least for a period of 12 months from the date of approval of rates. CGCDF will have the right to extend the validity of the tender approval by 3 months. We would communicate our rate approval within 45 days of opening of tender. If any tenderer wish to offer the rate subject to **PRICE ESCALATION CLAUSE** of raw materials, they may do so by clearly indicating in the tender rate form –B. In case of a tenderer opting for offering prices subject to PRICE ESCALATION CLAUSE of raw materials (i)then the tenderer shall have to submit the current price of the raw materials as on the date of tender along with sufficient authentic proof from the manufacturer of the raw material.
  - (ii) The successful/approved firm will have to submit revised prices of raw materials with sufficient authentic proof from the manufacturer of the raw material whenever revision takes place.
  - (iii) Accordingly the approved prices of the materials shall be revised upwardly or downwardly to the extent of the raw material component of the material.

    However CGCDF reserves the right to approve the rates offered with or without to PRICE ESCALATION CLAUSE.

- 8.0 The tenderer should quote rate on FOR dairy plant Bilaspur basis.
- 8.1 The tender should clearly specify quote rates are exclusive of **GST**.
- 8.2 The prices charged for the material supplies under the contract by the supplier firm in no event shall exceed the lowest price at which the supplier firm sells the material of identical tender description to any other persons/ firms during the period and until the execution of all supply orders placed during contract period.
- 8.3 Corrections, if any, in the tender should be noted over and signed at the places of each correction made.

### 9.0 **MODE OF DESPATCH**

- 9.1 The material to be supplied by successful firm shall be dispatched to the dairy under prior intimation. Depending upon the type of material, the supplier shall have to carry out proper packing/crating to avoid damage during transit. Payment will not be made for damaged goods.
- 9.2 FOOD GRADE CERTIFICATE: Certificate(s) of use of food grade quality of raw material are to be sent along with consignments where ever required.
- 9.3 Warferage/Demurrage etc. on account of incorrect or delayed dispatch of material/documents shall be the responsibility of supplier and shall be recovered from the bills.

### 10.0 **LIQUIDATED DAMAGES**;

Once firm delivery date(s) are fixed, they shall be strictly adhered to. In case they are not followed, Chhattisgarh Rajya Sahakari Dugdh Mahasangh Maryadit, Urla, Durg, reserves the right either to cancel the order and make alternative to work done, charge liquidated damages from him/her at the rate of 2% of the value of works not so done for each month's delay or part thereof. In case of delay the penalties would be deducted as under:

If the tenderer fails to make supply as per purchase order without any valid reason, the order would be treated as cancelled and the firm may be blacklisted for future dealings and EMD also would be forfeited.

### 12.0 <u>INSURANCE</u>

Insurance is to be arranged by the tenderer.

#### 13.0 **INSPECTION**

- All the materials supplies are subject to inspection at our stores before acceptance.
